### What we do

ChamberStudio provides year-round coaching and support for young professional chamber musicians in the fragile early stages of their careers.

We hold weekly Masterclasses at Kings Place in central London given by some of the world’s finest chamber music players and teachers.

This unique model allows ensembles to benefit from high level specialist coaching alongside the demands of busy freelance careers.

We also run a Mentorship scheme giving selected chamber ensembles the opportunity to study in depth for a year with a chosen Mentor.

### Why your support matters

Our work costs £80,000 a year. The musicians pay a heavily subsidised fee for Masterclasses and our Mentorship scheme – by far the costliest programme we run – is free. So we only recoup 10% of our costs in fees. We need to raise funds to cover the rest.

We receive no public funding and rely solely on support from trusts and individuals who care about the future of chamber music.
